TERMS & CONDITIONS

PARADE TO PARIS COMPETITION 2017 ("COMPETITION")

General

- The Competition is being conducted by The City of Norwood Payneham & St Peters, 175 The Parade, Norwood SA 5067 (ABN 11390194824) ("Promoter").
- 2. Entry into the Competition is deemed as acceptance of these Terms and Conditions.
- The Competition commences at 9.00am on Wednesday 7 June 2017 and closes at 5.00pm on Friday 28 July 2017 ("Closing Date and Time"). All Competition entries must be received by the Promoter prior to the Closing Date and Time.

Eligibility

Entering
