### General

1. The ‘Christmas in NPSP Advent Calendar’ (“Promotion”) is being conducted by the City of Norwood Payneham & St Peters, 175 The Parade, Norwood SA 5067 (ABN 11390194824) (“the Council”) in conjunction with businesses from within the City of Norwood Payneham & St Peters (“Participating Business”) for the period 1 December 2021 to 24 December 2021 (“Promotion Period”).
2. To enter the Promotion, entrants must enter their email address via the designated form on the Council’s website: [www.npsp.sa.gov.au/adventcalendar](http://www.npsp.sa.gov.au/adventcalendar).
3. One (1) promotional offer from a Participating Business will be sent to the entrant’s email address by the Council on each day during the Promotion Period in the form of an electronic voucher (“Offer”).
4. To redeem the Offer, entrants must either print out the email, or take their smart phone into the Participating Business and show the email to a staff member.
5. A maximum of one Offer per entrant, per Participating Business can be redeemed.
6. Specific terms and conditions apply to each Offer provided by a Participating Business, and the Council and the Participating Business reserve the right to limit the Offer to specific ranges at any time or to substitute the Offer in whole or part with another Offer of equal or greater value.
7. Travel and other incidental costs associated with entering the Promotion and claiming any Offers are the responsibility of the Entrant.
8. If for any reason the Promotion is not capable of running as planned or an Offer becomes unavailable for reasons beyond the control of the Council or the Participating Business, the Council and the Participating Business are under no obligation to provide a substitute Offer.

To the extent permitted by law, the Council is not responsible for any loss or damage whatsoever that is suffered (including but not limited to indirect or consequential loss) or for personal injury suffered or sustained by any person during the course of the Promotion or in connection with the redemption of an Offer.
