

TERMS & CONDITIONS

TASTE OF THE PARADE VOUCHER PROMOTION

Promotion details

1. 'Taste of The Parade' (the **Promotion**) is open to Australian residents aged 18 years or over.
2. The Promoter is The City of Norwood Payneham and St Peters, 175 The Parade Norwood SA 5067 (the **Promoter**).
3. The Promotion comprises an offering of vouchers (of which 500 are available) which provide a discount on purchases, to the value of \$25, for use at a business that is located within The Parade Precinct, in accordance with these Terms and Conditions (**Voucher**).
4. Registration is free.
5. Registration opens on Thursday 10 March 2022 at 12 noon ACDT and will close on Thursday 24 March 2022 at 12 noon ACDT (the **Registration Period**).
6. To participate in this Promotion, applicants must complete the form at <https://www.theparadenorwood.com/offers/taste-of-the-parade> (the **Website**) during the Registration Period.
7. Any person who completes registration on the Website in connection with the Promotion is, by the action of registration, deemed to have considered and then accepted these Terms and Conditions.
8. As part of the registration form, applicants will be required to nominate one of the hospitality businesses within The Parade Precinct as listed on the Website (the **Nominated Business**). The Website will display the list of participating businesses in a drop-down list.
9. The list of participating businesses is subject to change at any point in time. Should this occur and as part of the registration form, an applicant has nominated a business that is no longer wanting to participate, the applicant will be notified and will be able to select another business from the participating business list.
10. Applicants must provide an active email address. In the event that the Promoter (or any third-party contractor of the Promoter) is unable to deliver a Voucher to an email address on the first attempt, the applicant's registration will be deemed incomplete for the purposes of the Promotion.
11. An applicant may only apply for one (1) Voucher. Any second or subsequent application submitted by the same applicant will be disregarded.
12. The first 500 eligible applicants will receive one (1) Voucher which can be redeemed at the Nominated Business.

Eligibility

13. An applicant who is to receive a Voucher will be notified by Monday 28 March 2022 by email (using the email address supplied during the registration process).
14. The following persons are not eligible to apply for a Voucher:
 - a. Elected Members and officers or employees of the Promoter and members of their respective immediate families (being any person within the definition of '*relative*' in the *Local Government Act 1999*); and
 - b. any other person involved in the conduct of the Promotion (whether as a principal, agent or employee), including but not limited to any officer or employee of any eligible participating business.
15. Each applicant agrees, by virtue of registering to be a part of the Promotion, to have their details recorded and to receive further future promotional emails from the Promoter.
16. Each applicant's personal information is being collected by the Promoter to determine their eligibility to participate in the Promotion and to provide future marketing information to them. If an applicant fails to provide the personal information that is requested will not be considered to be a participant in this Promotion.

Voucher Redemption

17. Subject to clause 18, in order to redeem a Voucher, a successful applicant must spend a minimum of \$35 in one (1) transaction at the Nominated Business.
18. If a successful applicant who has received a Voucher is dining together with one or more other successful applicants who are also in possession of a Voucher for the same Nominated Business, a minimum of \$35 per person who is using a Voucher must be made (i.e. if two (2) people each want to redeem their Vouchers, a minimum of a \$70 combined expenditure must be made in order to redeem the combined \$50 under the Voucher and for three (3) people, this will increase to a \$105 combined expenditure in order to redeem \$75 and so on).
19. Nominated Businesses which receive a nomination/s for a Voucher redemption will receive a list of first initials and last names only for those applicants, except in the event of duplicates where a first name will also be provided.
20. Each Nominated Business is responsible for managing the redemption of any Voucher issued in connection with that Nominated Business.
21. A Voucher must be redeemed prior to 11:59pm on Sunday 1 May 2022 (**Expiry Date**).
22. Any Voucher that is not be redeemed prior to the Expiry Date, is forfeited without any entitlement to any form of compensation. Accordingly, a Nominated Business is entitled to refuse to accept a Voucher after the Expiry Date.
23. Vouchers are not redeemable for cash.
24. The Promoter does not accept any responsibility for the loss or duplication of any Voucher.

Secondary Allocation

25. If:

- a. the allocation of Vouchers is not exhausted during the Registration Period; or
- b. a Voucher issued during the Registration Period is not redeemed by the Expiry Date, a secondary allocation of un-redeemed vouchers may occur, at the absolute discretion of the Promoter

(the **Secondary Allocation**).

26. To avoid doubt:

- a. a person who has received a Voucher during the Registration Period is not entitled to participate in any Secondary Allocation; and
- b. with the exception of clauses 5, 13 and 21, these Terms and Conditions have the same application to a Secondary Allocation as they do during the Registration Period.

27. A Secondary Allocation period will commence (if necessary) on Friday 6 May 2022 until Sunday 12 June 2022 and recipients of the remaining Vouchers will be notified by Friday 6 May 2022.

28. A Voucher must be redeemed prior to 11:59pm on Sunday 12 June 2022 (**Secondary Expiry Date**).

29. Any Vouchers which are not issued or redeemed as part of the Secondary Allocation will be forfeited.
